Dana Bove, 1935 Tin Cup Ct., Boulder. He asked what actions have been taken regarding prairie dog presence and recovery of vegetation.

Jeff Moline: He responded that staff have done the work and removed prairie dogs from the site to the relocation site. That property will now be brought into agricultural production. As a result, better habitat will be provided on Rock Creek Farm.

Karen Blakemore, 92 Wildewood Dr., Nederland. She asked when the resource maps will be updated.

Jeff Moline: The maps will be updated after adoption by the Planning Commission.

Heidi Wagner responded that CP&P and the City of Boulder will be consulted regarding possible connections. The community will have a suite of options presented to them for feedback.

Lisa Langer, 11628 Kenosha Rd. She voiced that one thing that missing in the presentation and website are images of wildlife and wildlife habitat.

- BOCC approved the acquisitions of the State Land Board parcels on Bald Mountain and Heil Valley Ranch.
- The bilingual Partnership Coordinator position has been filled by Monserrat Alvarez.
- The Universal Sign Pilot Project is underway at Walden Ponds. It will be expanded to our entire county park system soon.
- A Small Grant symposium, which is held jointly with OSMP and Jefferson County, will be held on April 14, 2023 at the CU East Campus. Watch for more information. The deadline for to submit research proposals to Boulder County is Monday, Jan. 9, 2023. gov/research
- Annual recruitment for our Volunteer Naturalist positions has wrapped up.
- Long-term monitoring of Limber pines has begun. It's a species of special concern.
- 258 prairie dogs were relocated from the Carolyn Holmberg Preserve to our South County Grasslands.

- Meadowlark Trail reconstruction work has finished. Monarch and Twin Lakes trail work is next.
- An appreciation dinner for our agricultural tenants will be Feb. 8.
