BCHA is applying for this grant to supplement its existing Supportive Housing programs and funding sources available for vulnerable, precariously housed or homeless families with school-aged children, which currently include HUD Continuum of Care Rapid Rehousing funds (CoC RRH), local HSSN funds administered through our Housing Stabilization Program, Family Unification Program vouchers, and the Family Self-Sufficiency Program. If awarded, funding for this program will be able to assist approximately 15 - 20 families in any given month with rental and security deposit assistance and case management supports. We hope to target these resources to families who are doubled-up/couch surfing, as they do not qualify for the HUD CoC RRH program, due to not meeting the definition of

literal homelessness, but would be eligible under the Next Steps program, thereby filling a gap in our

housing resources continuum.
