

ELECTED OFFICE UPDATES

- Coroner's Office
 - Applying for national accreditation implementing data management software to develop, approve, distribute, and track policy and procedures needed for accreditation
 - National certification for their deputy coroners in medico-legal death investigation



- District Attorney's Office
 - Prioritize effective prosecution of violent offenses, including homicides, gun violence, sex offenses, vehicular homicides, and domestic violence
 - Develop path forward for Family Justice Center in Boulder County
 - Prevention efforts, such as, seeking to reduce gun violence and hate crimes
 - Continue to push for more behavioral health treatment in the justice system and our communities

ELECTED OFFICE UPDATES

- Sheriff's Office
 - Continue to implement changes and upgrades based upon lessons learned from the Marshall Fire
 - Ballot measure 1A planning and management of funds used to enhance search and rescue services and the work of wildfire mitigation
 - New alternative sentence facility and a new intake building on the jail campus



- Surveyor's Office
 - Continue to respond to survey needs throughout the county and in areas affected by the Marshall Fire
- Treasurer's Office
 - Continue to collect taxes for and distribute monies to all taxing districts
 - Continue to act as public trustee
