The resolution perpetually extending the transportation sales tax (Resolution 22-048) says the proceeds of the tax may be spent "for the purposes of funding transportation improvements." Paragraph 12 then says this is "including, but not limited to" and has a list of different types of projects, two of which reference maintenance (maintenance of transit service and maintenance of regional trails, multi-use paths and bikeways). Paragraph 13 then says that "[e]xpenditures related to the above activities may include but are not limited to planning, design, construction, operations, maintenance, and administration." Because Paragraph 12 lists everything I can think of that PW does related to transportation and roads, including road and bridge infrastructure in addition to transit and trails, I interpret the resolution to broadly permit the proceeds of the sales tax to be used on maintenance of transportation infrastructure.

If I am understanding this situation and the question correctly, both RST1 and RM1 are each currently components within the Road and Bridge Fund. If so, there is no potential for there to be a legal issue if the county is to transfer funds from RST to RM1. The only statutory constraint on usage of moneys in the Road and Bridge Fund is that they are not removed from the Road and Bridge Fund and expended on purposes other than roads and bridges. Since both RST1 and RM1 are both sub-parts of the Road and Bridge Fund, necessarily they are already limited to road and bridge purposes. The fact that we have elected to split the Road and Bridge Fund into two separate buckets doesn't change the simple rule from the statute that the moneys in the Road and Bridge Fund must be expended on roads and bridges.

RMI is the appropriation that is funded by property tax and other misc revenues such as Highway User Tax. Its use is not project based but rather maintenance based; for example snow plowing, pot hole filling etc. So the question is legally can we use some of the sales tax revenues (RST) for maintenance purposes?

There's been some discussion of re-allocating Road & Bridge fund balance from RST1 (Road SUT Projects) into RM11 (Road & Bridge Projects), because of the shortage of fund balance in RM1. Jeff Maxwell had received "unofficial" approval from the Board (see attached email), but we wanted to check in with you first in regards to the legal piece to determine if this transfer is allowable. This potential transfer would affect funds prior to 2024, so this does not apply to the recently approved extension that will take place in 2024.

At the end of 2022, the unaudited ending fund balance for Fund 111 (Road & Bridge) is positive by approximately \$12M; however, RM1 is a negative \$1.5M, while RST is positive by \$13.5M. Historically, RM1's fund balance has struggled because of the flood. For example, the ending balance for RM11 in 2019 was approximately -\$40M. Fund 111 has received flood reimbursements in hopes to recoup some of that negative RM1 fund balance, but recently, the Commissioners have determined those reimbursements will now go to the General Fund (101) because RM1 is close to a positive balance. Because of this, and the lack of funding available, Jeff had proposed transferring a portion of RST1's fund balance to RM11 through an intra-fund transfer.

Can you please provide some detail to determine if this intra-fund transfer is allowable? Is there any language written into the ballot measure that would prevent this transfer?



I've attached the PowerPoint I presented to the Board yesterday during the Public Works PMI. Claire, Marta and Jana were in attendance. Both Claire and Marta approved of moving forward this year with the following Public Works construction projects:

- Road surface overlays on Hygiene Road, 2<sup>nd</sup> Ave Niwot, Reserve Drive. Cost: \$930K
- Major/minor structure replacement on Riverside at Cave Creek and 51st at Dry Creek #2. Cost: \$980k

Fund revenues and also as a note for the file that we may need that amendment to move funds between appropriations later this year. Onward!

- Bridge replacement on 119<sup>th</sup> over St. Vrain Creek. Cost:\$445k
- Total cost: \$2,355M
