Recommendation:

The evaluation committee unanimously recommends awarding RFP #7488-23, Comprehensive Wellness Program, to Healthbreak, Inc.

While Healthbreak came very close to the lowest bid, their combination of services, integration with third-party apps, robust coaching, best in class wellness platform, local presence, ability to deliver on all requirements, and their years of experience with Boulder County led to the highest ranking amongst the bidders. Healthbreak also suggested some further enhancements to our wellness programming and incentive structure including increasing the total gift card awards from \$125.00 to \$200.00 annually to bring us closer in line with our benchmarks. They were also the only bidder with an MWDBE status.

The proposal with slightly lower fees did not provide the same level of platform functionality or social connections, and their lack of third-party app integrations would have meant taking away our existing mindfulness, financial, nutritional, and instructional workout programming for our employees. The proposal with higher fees utilized the same Virgin Pulse platform; however, we could have only realized the same functionality if we upgraded to a custom program which would have been even more money. Neither the quoted offering nor the custom program demonstrated an added value to justify an increase in spend. Based on this, the panel felt that Healthbreak submitted the most responsible proposal for Comprehensive Wellness Program services.

Budget:

Healthbreak will guarantee pricing for platform and coaching for 3 years with a onetime increase of 4% at year 4 for the remainder of the contract. Fees for biometric screenings will remain fixed for the entire contract, unless the screening vendor, PHN, has a rate increase, which cannot exceed 5% annually or the County chooses a different provider. Wellness Program Administration fees for service team will increase 3.5% annually. The total cost for these services for January 1, 2024-December 31, 2024 will not exceed \$547,000.00. This includes the platform, account management, biometric screenings, programming, challenges, incentives/gift cards, coaching, and third-party app integrations. This amount is also offset by a wellness program reimbursement of \$150,000.00 every year from Cigna.
