Subject: Metro Football District Advisory Committee Funding Recommendations

As part of the sale of the Denver Broncos, 2% of the net profit was allocated to the Metropolitan Football Stadium District through terms of the original lease and management agreement between the stadium district and PDB Sports LTD. Boulder County, which is a part of the stadium district, received \$309,220. On June 20, 2023, the Board of County Commissioners appointed the following applicants to the Metro Football District Advisory Committee (further referred to as "Advisory Committee"):

This Advisory Committee was tasked with making funding recommendations to the Commissioners on how the \$309,220 should be spent. According to Metropolitan Stadium District Resolution 22-05, under the Act and Article 33 of the Lease, the sharing amount of funds received by Boulder County are to be used for "youth activity programs".

The Advisory Committee received 82 applications totaling \$2,149,679.18 in funding requests. Throughout their review process the Advisory Committee met three times (hybrid meetings) July 28th at 10 AM, August 8th at 3:30 PM, and September 25th at 10 AM. Throughout these meetings, the Advisory Committee created a process to evaluate the funding request applications as explained –

Each Advisory Committee member independently reviewed each application using the following criteria:

- 1. Does this project or program serve the Boulder County community? Yes / No
- 2. Does the project or program serve "youth"? Yes/ No
 - a. "Youth" is defined as 0-21 years old; up to 24 years old for individuals with I/DD or disabilities.
- 3. Does this project serve underserved communities? Yes/ No
 - a. "Underserved" was not explicitly defined.

- 4. Does this organization show financial and operational sustainability through their application? Yes/ No
- 5. Depth of impact: 1-5
 - i. 1- minimal to no impact
 - ii. 2 -limited impact
 - iii. 3 adequate impact
 - iv. 4 immense impact
 - v. 5 transformational impact
- 6. Number of Youth Served: 1-5 (values 2-4 left blank and fall between the narrative of "very few youth" and "reaching most youth in the community")
 - i. 1- very few youth will be served
 - ii. 2- (intentionally left blank)
 - iii. 3 (intentionally left blank)
 - iv. 4- (intentionally left blank)
 - v. 5- reaching most youth in the community
- 7. Ranking of clarity of the vision and ability to implement the project or program: 1-5
 - i. 1 Poor
 - ii. 2 Insufficient or unsatisfactory
 - iii. 3 Satisfactory or meets expectations
 - iv. 4 Above expectations
 - v. 5- Outstanding

Following the reviews, the staff liaison collected responses from six responding members of the Advisory Committee (a quorum of the Advisory Committee) and eliminated any applications that received a "No" in categories 1-4, as those were considered requirements to receive funding by the Advisory Committee. The remaining applications were then ranked using their average scores received in categories 5-7. Following this analysis, 23 applications remained.

The Advisory Committee met and discussed the remaining 23 applications to determine how to allocate the \$309,220. In their assessment the Advisory Committee included the following criteria how they came to their final funding recommendation:

- Geography of the county, specifically that the mountain communities received funding for youth activities.
- Applications' average rankings received from the Advisory Committee's review of categories 5-7 (listed above)
- Applicants who have received funding from Boulder County or the Boulder County Commissioners' Office already in 2023 (including but not limited to – Worthy Cause funds, SCFD funds, and Commissioners' Office DEI funds)

Using these criteria, the Advisory Committee created a "Zone Funding" approach that allocated either 100%, 75%, 50%, or 25% funding for each of the remaining 23 applications. The final funding recommendation to the Boulder County Board of Commissioners is as follows:
