

Boulder County will lead the way to Pesticide-free Colorado, one day. Hopefully sooner than later. Here you will see a list of municipalities all over the country limiting pesticides and Boulder County's list is already long:

As you can see Lyons isn't even listed. However Lyons uses only USDA approved substances. It's time **Boulder County enacted a USDA Organic Approved Pesticides Only Ordinance** as well (remember anyone over 40, was blessed with the privilege of a mostly organic life, young people today are bombarded with chemicals). Also the City of Boulder says most of pesticides miss the target and harm ecosystems:

More Reasons (besides health and climate) to end Pesticides:

1 - Richard Andrews 115 research articles around the bonafide dangers of glyphosate, and the numerous lawsuits, it would be **negligent** to use this toxin any longer (this will likely happen with other pesticides),

2 - BCPOS must show the research confirming that Restore CO '22 (spraying of Rejuvra which is 59-80% "inert" or **unknown ingredients**) will in fact produce **fire mitigating properties** bc this info has spread a lot of fear in the community (Boulder Weekly article) and **we need proof** that it's substantiated,

3 - Some of BCPOS lists "endorsements" from New Weed Mgmt. Plan **deny giving their endorsements**: Patty Butler of CO Native Plant Society and Patty York from CO Dept. of Ag.

4 - POS's war on invasive/non-natives in the name of "functionality for wildlife" is misaligned to say the least:

Chronic wasting disease (CWD) is a concern, it's interesting that it was first reported in CO around the same time pesticides started being sprayed in the 1960s. Rejuvra is a neurological disruptor and CWD is neurological disease, **so until we know there is no correlation between the use of pesticides and CWD, POS should halt all pesticides** for their very own reasons stated on the Weed Walks.

5 - Did you see Therese Glowaki's denial that Dr. Tim Seasteadt is an expert is cheatgrass? Her plan to work with the University of Idaho and CO State University, when **Dr. Tim Seasteadt at CU is in fact one of the top experts on cheatgrass** in the world; this is unbelievable if she really wants to manage cheatgrass.

6 - Because leaders at POS are not ecologists, scientists and are therefore not qualified to monitor adverse effects of pesticides. They don't know the real costs of their methods, they only look at **ONE aspect of ESG (Environmental, Social and Governance) we need leaders who look at Environment and Social** and BCPOS is only strong in Governing themselves,

7 - BCPOS is arrogant. They couldn't even remember that they promised POSAC they would monitor the risks, or decrease pesticides over time. They took Commissioner

Ashley Sholtzman to a site in the City of Boulder that's been managed WITH pesticides and her request was the opposite. They aren't trusted by elders who have been dealing with their broken promises for decades. Voters will NOT allocate funds to BCPOS with their current aerial spraying policy.

So until it's "in writing" they will not change. Lyons Parks and Open Space didn't change, either, until the DandyLyonsBrigade and Town Leaders Petitioned to Ordinance, but unfortunately we can't do that on a County level due to state laws. Your constituents' hands are tied.

So, please, Commissioner tie their hands with an Organic Ordinance. This requires POS to focus on soil health and prioritize species that are List A or B. The time will eventually come, make it NOW.

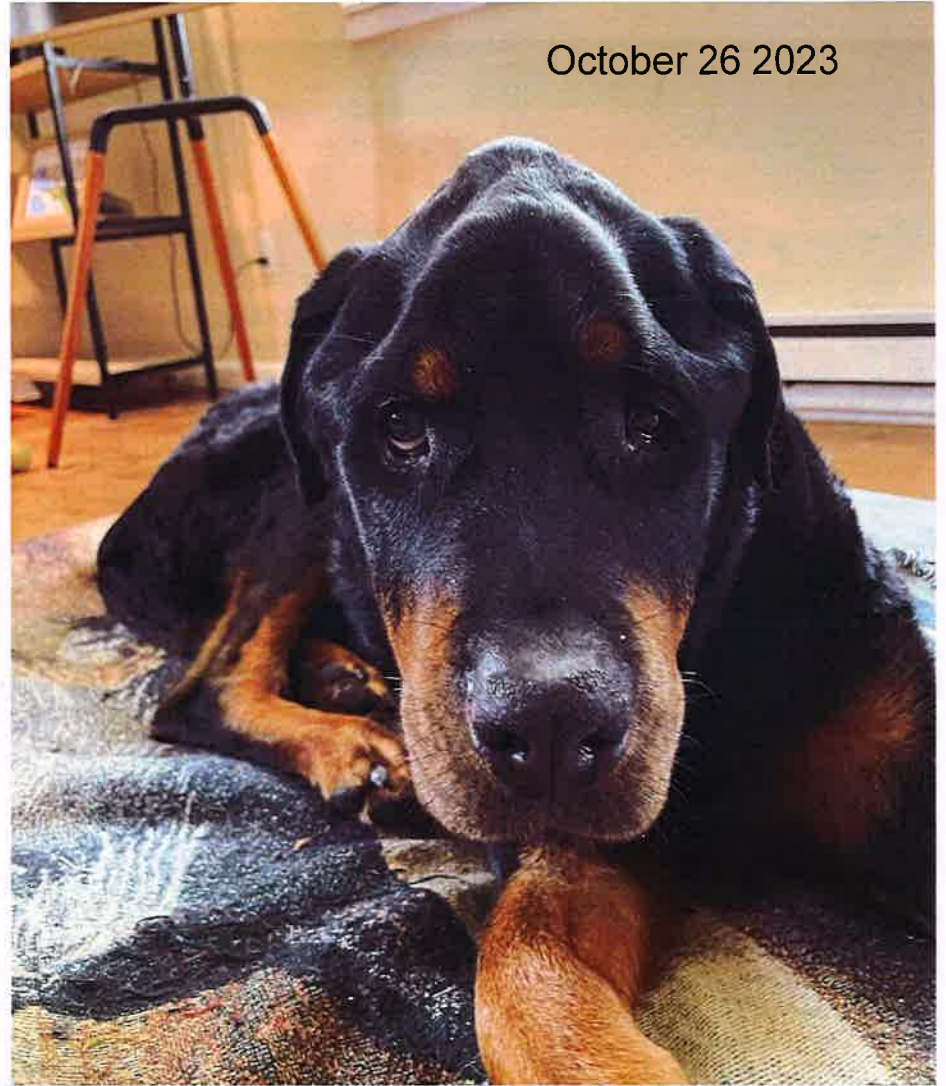

request for specific chemicals to be removed from IWMP

All chemicals listed on pages 47 through 55 have varying levels of toxicity but here is a list I think should be immediately discontinued because their use rate values are the highest in Herbicide Use Table 1:

- 2 4-D
- Dicamba
- Fluroxypyr
- Glyphosate
- Imazamox
- Imazapyr
- Quinclorac

While the EIQ-FUR says low or very low for most of these chemicals, the upper end of the use rate values are between 19.7-46.6 so they are the most unsafe chemicals in the lists.

There are other chemicals with lower use rate values, the safety of which I don't trust, that I have covered in depth over the last few months. Among these are:

- Milestone
- Indaziflam/Rejuvra
- Aminocyclopyrachlor and Clopyralid could be added because of the similarity to other chemicals in these lists
