Public Works Department/Office:

Description: The Public Works Department (and Risk Management) is requesting a one-time increase of \$384,976

for fleet replacement vehicles (77030-Equipment) for Housing & Human Services, Coroner's Office, and

Community Services.

Several vehicles were significantly damaged due to a hailstorm on May 9, 2023. This resulted in 7 claims with totaled units. Our Self-insured retention for these claims is \$100,000 so the full amount of each replacement vehicle will not be covered by insurance.

Risk considers a vehicle a total loss when the estimate to repair reaches 75% of the value. These units would be totaled at the 75% amount. This is industry standard practice for determining when a vehicle is totaled. Once replaced, Fleet will sell the units at county auction or through a salvage company to recover any possible salvage value. Revenue received from salvage or selling of vehicles will be booked and received at a later date. Please see attachment detail for quote breakout of 7 vehicles.
