Boulder County Head Start (BCHS) is requesting approval to submit a Buell Grant application for the 2024/25 school year (August to May).

The Buell grant program has a total of \$75,000.00 in grant funds to distribute in support of Bilingual - Early Childhood Mental Health Consultant (ECMHC) services to BCHS staff, children, and families. Consultation by the ECMHC includes classroom observations, identifying and implementing strategies that support healthy social-emotional development and mental health in the classroom and at home, researching and presenting evidence-based training for staff during monthly professional development, and community partnership with other health service providers (ie., Mental Health Partners).

BCHS has been awarded these grant funds annually since 2016 to address the goals and community needs below, relating to increasing access to and support for staff and families in health and wellness. Receipt of these funds will not require the hiring of additional staff, nor will a match of funds be required due to the generous Head Start subsidy already received from the BOCC.
