SUBJECT: Waiver of Bid Requirements for ConvergeOne

Executive Summary:

Information Technology requests a waiver of the bid requirements for ConvergeOne, our current reseller for Cisco, Duo, VMware, PureStorage, and A10. The National Association of State Procurement Officials ("NASPO") has negotiated with ConvergeOne for favorable pricing and products on behalf of state and local governments and the county may take advantage of those terms and pricing.

We anticipate ongoing purchases from ConvergeOne for these and other services.

Total amount not to exceed \$5,675,000 over the course of five years, with no single year exceeding \$1,135,000.

Action Requested:

Waive the formal bidding process for software procured through ConvergeOne as a Participating Entity under NASPO Master Agreement AR3227 and the State of Colorado Participating Addendum #172938.
