Reference: DOLA GRAY & BLACK MARKET MARIJUANA ENFORCEMENT GRANT PROGRAM APPLICATION

I request approval from the Board of County Commissioners (BOCC) to opt into the Colorado Department of Local Affairs (DOLA) Gray and Black Market Marijuana (GBMM) Enforcement Grant Program. The purpose of the program is to assist local law enforcement agencies and district attorneys with investigation and prosecution costs associated with unlicensed marijuana cultivation or distribution operations. The grant opt in process requires applicants to provide the date of official board action in support of the application as an assurance of community priority. Applications cannot be submitted unless approved by the city/town/county board, council or trustees prior.

The BOCC has been supported of this grant program these past six grant processes and the Boulder County Drug Task Force has been able to effectively and efficiently use the program funds to assist in investigations and purchase of personnel protection equipment (PPE).

#### **Total Funding Available and Application deadline**

- \$790,000 annually (including program operations) Fiscal Year 2024-2025
- Application opens: September 17, 2024
- Application closes: October 18, 2024

DOLA will provide financial assistance based on population, the dollar amounts available, and the number of agencies that opted into the program.

Boulder County is the recipient of the grant application rather than a single department within the county. If funding is approved, I will serve as the responsible administrator completing quarterly reporting as well as oversight of grant funding expenditures and budgeting. My current assignment with the Boulder County Sheriff's Office includes oversight of the Boulder County Drug Task Force (BCDTF) which is a Boulder County multiagency group that investigates an array of drug related incidents, crimes and assists in other investigations in Boulder County where our skill set is requested. The BCDTF also investigates illegal marijuana grows and distributors. The grant funding will support the purchase of safety equipment required for the handling and destruction of marijuana, assist with the operational costs of investigations, and offset overtime expenses for both investigation and prosecution purposes. District Attorney Michael Dougherty is supportive of this grant funding program.

Thank you for your time and consideration and I have provided two DOLA informational documents which provide further details on the grant and the requirements.
